Total receipts were \$45.00, total expenditures were \$655.00, a negative cash flow for the month of \$605.00. The ending checking account balance is \$6,219.20 less our prudent reserve of \$1,875.00. We have a balance of \$4,344.20 going into 2023. However, we have increased budget to \$8,100 (was \$7,300) so we need to be mindful as the year continues. We are hopeful that group donations will increase as well. *From Eddie, "A big thank you for allowing and trusting me to be the D31 Treasurer for the past two years, it was my pleasure serving you."*
