

#### **NEW BUSINESS**

#### District Member Voting

- ➤ Karon M: "It was brought to my attention, with the New Year, that we should clarify the vote process for new district members as there are some members of D31 that hold two positions: 1) a committee position and 2) a GSR position for their home group. We want to make it clearly understood that if you are voting at Area you are entitled TO ONE VOTE as a GSR for your group. Only the DCM and ALT DCM have votes on behalf of the district.
- At our district level, D31 has a current policy that allows votes in both positions and the group today discussed:
  - Patricia H asked that each GSR ask their Groups to actively seek to fill the GSR and Alternate trusted servant positions
  - Doug talked about the need for Rotations at Groups for trusted servants and the importance of this practice.
  - Many members shared their experience and frustration with the lack of willingness and commitment by home group members to serve as trusted servants and/or participate at the service level.
  - DCM asked if the group would like to vote to keep the policy at the district level the same at this time. Majority was Yes.

#### Storage of D31 Supplies

- Over the years, D31 has accumulated many bins of supplies that have moved from garage to garage. The group is seeking to find a central location where items are accessible to more than one or two people. Items include but not limited to:
  - Paper goods, Coffee Urn, etc. (used for meetings)
    - With group 494 approval these supplies will be stored at 494
  - Items for Public Information
    - Leann is currently collecting all items including literature racks, and literature and will need a space for storage
  - Posters for Founders Day (Old Timers / Archive materials) (Donna H temporarily storing these posters at her home.)
- Discussion held and it was agreed to have an Ad-Hoc committee
  - Patricia H. will obtain pricing for storage facilities and provide D31 with the information at next meeting.
  - Leann will do district inventory of all literature and materials to determine amount of space required.
